### Notice of Specially Called Meeting



A very brief membership meeting will be held just before the Halloween party on Thursday, October 28, 1999 at 5:55 p.m. (or as soon thereafter as we have a quorum) at the Lynne Farris Gallery, Hurt Building Lobby, 50 Hurt Plaza, Atlanta, Georgia 30303. The purpose of the meeting will be to consider amending Article II, Section 2 of the Section Bylaws, which currently reads as follows:

“Each officer shall hold office for a term of one year commencing immediately following each annual meeting of the Section and continuing for a period of one year until his/her successor has been elected and qualified”

*Explanation:* The Sections have been encouraged by the State Bar to make their officers' terms of office coincide with the State Bar Year, which runs from June to June. Under our current bylaws, the term of office runs from January to January (since our annual meeting is normally held at the "Midyear" Bar meeting, which occurs in January). As it happens, this year the new officers were not elected until well into the spring and did not assume office until approximately June anyway, so we would not really be extending the current terms.

### Georgia Diversity Program Committee

Section Chair Susan Garrett and Treasurer Megan Gideon have been appointed by State Bar President Rudy Patterson to serve on the Georgia Diversity Program Committee. The Georgia Diversity Program seeks to increase opportunities for ethnic minority attorneys in the assignment of corporate and government legal work. We have invited the other members of the committee to the Section Halloween Party so that the groups can get to know each other.


