In order to practice law in Georgia, you must enroll within 60 days after being sworn in to avoid paying a \$100 Late Registration Fee. If applicable, add in at Section F and include Failure to Register Affidavit. Your license fee obligation is based on the date you are sworn in to Superior Court. The State Bar of Georgia's fiscal year is July 1 through June 30. If you are enrolling late, you could owe two years of license fees based on your sworn in date.

**MANDATORY ASSESSMENTS**

**Clients' Security Fund (CSF)**

Provides a remedy of last resort for clients whose funds were mishandled by their attorney. See Rule 1-506.
