In order to practice law in Georgia, you must enroll within 60 days after being sworn-in to avoid paying a \$100 Late Registration fee. If applicable, add in at Section E and include Failure to Register Affidavit. Your license fee obligation is based on the date you are sworn in to Superior Court. The State Bar of Georgia's fiscal year is July 1 thru June 30. If you are enrolling late, you could owe two years of dues based on your sworn in date.

Assessments-Mandatory: Clients' Security Fund (CSF) - Provides a remedy of last resort for clients whose funds were mishandled by their attorney. See Rule 1-506.

Bar Facility Assessment (BFA) - Used to purchase, maintain and operate State Bar offices. See Rule 1-507.

Contributions-Optional: Legislative & Public Education Fund-Optional \$100: Allows the Bar to maintain a strong and active voice on behalf of its members in supporting or opposing issues of importance to the administration of justice in Georgia.

Georgia Legal Services Program: Your GLSP donation is tax deductible. This program provides civil legal services for Georgia's poorest residents and helps guarantee equal access to justice, so please give generously. The suggested donation is \$300.
